205. 20/0330/TRE Mrs Newcombe

9 Garrett Close, Seaton EX12 2FE
T1: Sycamore - dismantle and fell.
Reason - Infected with sooty bark disease.

Discussion took place around:

- Question 4 on the planning application form states 'Are you seeking consent for works to tree(s) subject to a Tree Preservation Order'? The agent has answered 'Yes' but Question 6 states 'Please note: If none of the proposed work involves trees covered by a TPO, please answer 'No' to the two questions below. The agent has ticked 'No' to both questions indicating that the tree does not have a TPO on it. This is contradictory information and Councillors were asking is there a TPO on the tree or not? Councillors felt the application was flawed and more information with a report is required detailing why the tree needs to be dismantled, if it has a TPO, before Councillors felt they could comment further.

The Committee **RESOLVED** to ask for more information concerning the application before they send any comments into the district council.

The Committee noted the planning decision made by East Devon District Council:

- a) 19/2800/FUL - Land At Manor Close Manor Road Seaton** Replacement of existing external staircases, new ramps and steps, widened paths, raised platforms and altered bin stores – **APPROVED** – with conditions
- b) 20/0074/FUL – 29 Elizabeth Road, Seaton** Construction of single storey rear extension - **APPROVED** – with conditions
- c) 20/0079/FUL – 17 Upper Churston Rise, Seaton** Extend conservatory to cover external stairs, construct decking at ground level below conservatory; construct pergola around decking, add porch between base of stairs and basement door - **APPROVED** – standard time limit
- d) 20/0136/FUL – 9 Elmfield Road, Seaton** Construction of a single storey extension– **APPROVED** – standard time limit
- e) 20/0102/FUL – 4 Trevelyan Road, Seaton** Internal alterations to facilitate creation of 1 no. additional flat; insertion of full height opening and juliet balcony at first floor level on east elevation and extension to 2 no. dormers and construction of balcony at second floor level on east elevation – **WITHDRAWN**
