Discussion took place around:

- The lighting for Windsor Gardens the Town Clerk confirmed that quotes would be going to the Finance and General Purposes Committee next week
- The timing of the Artisan Market and that it would run from 4pm to 8pm
- Shops in the town to be asked if they will be opening on Saturdays 1st and 8th December
- The choirs the Town Clerk confirmed that both Seaton Primary School and the Axe Valley Community Choir had been approached regarding the Christmas Light Switch on but to date no reply had been received
- The idea to put trees in the holders above shops not feasible to do this for Christmas 2018 as not enough shops have tree holders and discussions need to be had with a number of landlords to make this happen
