# Minutes of the Finance & General Purposes Committee Meeting on Monday 24<sup>th</sup> September 2018

# 79. Marshlands Office Space

Discussion took place around:

- The need to add a service charge to the rental fee
- To review the costs of utilities for 12 months and to pro rata across the building based on the floorspace
- The Town Clerk to check on the VAT implications for the room rentals, utility bills, etc
- The business rates to be a matter for the tenant to sort out with East Devon District Council and not included in the rental fee
- The offices will not be serviced i.e. cleaned but there will be cleaning of the communal areas included as part of the service charge
- The need to have an inventory of all furniture
- Whether internet access would be included or whether this is something for the tenant to arrange themselves

### The Committee RESOLVED that:

- Rental charges for the offices on the first floor be set at the following fees plus an additional 10% be added to this as a service charge:
  - o Room 1 £2,250 per annum
  - Room 2 £2,025 per annum
  - o Room 3 £2,465 per annum
  - o Room 4 £1,250 per annum
- The Town Clerk to check whether VAT is applicable to any part of the fee or service charge
- Business Rates are excluded from the rental fee

- The rooms will be marketed by the Council using existing Tenancy at Will paperwork
- The tenant will be responsible for arranging their own internet/Wi-Fi connection
- Furniture to be included
