**THE COUNTY OF DEVON (TEMPORARY RESTRICTION) (SEATON CHRISTMAS CARNIVAL & CHRISTMAS LIGHT SWITCH ON, SEATON) ORDER 2021**

**TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING**

**NOTICE** is hereby given that Devon County Council has made the above titled order.

On **SATURDAY 27 NOVEMBER 2021**  
for a maximum of 3 days

Anticipated Finish **SATURDAY 27 NOVEMBER 2021**

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads except for access to land or premises on or adjacent to those length of roads.

Roads affected – Between the hours of **16:30** and **20:30**

**HARBOUR ROAD** Between The Underfleet and Marine Place. **FORE STREET** between Cross Street and Marine Place. **MARINE PLACE and QUEEN STREET.**

The alternative, signed, route for vehicles will be via - UNDERFLEET, MANOR ROAD, FORE STREET, CROSS STREET, HAREPATH ROAD, SEATON DOWN ROAD, MARLPITS LANE, BEER ROAD, SEA HILL, THE ESPLANADE, HARBOUR ROAD AND BEACH ROAD.

Roads affected - Between the hours of **18:00** and **20:00**

**FORE STREET AND THE UNDERFLEET.**

Roads affected - Between the hours of **19:00** and **21:00**

**THE ESPLANADE** Between Beach Road and Marine Place. **FISHERMANS GAP.**

The alternative, signed, route for vehicles will be via - BEER ROAD, MARLPIT LANE, SEATON DOWN ROAD, SEATON DOWN HILL, HAREPATH ROAD, VALLEY VIEW, MANOR ROAD, FORE STREET, SEATON ROAD, COLYFORD ROAD, HARBOUR ROAD, A3052 B3172 AND AXMOUTH ROAD.

No person shall cause or permit any vehicle to wait on the sections of Affected Roads except for access to land or premises on or adjacent to those length of roads.

Roads affected - Between the hours of **17:00** and **21:00**
