

## **Devon County Council (East Devon HATOC) (Traffic Regulation) Amendment Order**

Devon County Council propose to make this under the Road Traffic Regulation Act 1984 to introduce:

Axminster: **No Waiting At Any Time** on specified lengths of Sector Lane, Tigers Way and Woodbury Park;

Beer: **No Waiting At Any Time** on specified lengths of Berry Hill, Fore Street and Short Furlong;

Broadclyst: **No Waiting At Any Time** on specified lengths of Road From Tower View To Dog Village Cross and Station Road;

Budlake: **No Waiting At Any Time** on specified lengths of Ellerhayes, Lane To Francis Court Cottages, Road From Danes Cross To The Firs and Road Past North Lodge;

Budleigh Salterton: **No Waiting At Any Time** on specified lengths of East Budleigh Road, Fore Street and High Street; **No Loading At Any Time** on specified lengths of Cliff Terrace;

Clyst Honiton: **No Waiting At Any Time** on a specified length of Road From Honiton Road To Pound Corner;

Clyst St Geroge: **School Entrance Clearway - No Stopping At Any Time** on specified lengths of Road From Addlepool Farm to Model Cottages;

Colyton: **No Waiting At Any Time** on specified lengths of Queens Court;

Exmouth: **No Waiting At Any Time** on specified lengths of Buckingham Close, Douglas Avenue, Foxholes Hill, Hamilton Lane, Hulham Road, Long Causeway, Louisa Place, Marcus Road, Mayfield Drive, Phear Avenue, Raddenstile Lane and St Johns Road; **Prohibition Of Motor Caravans 8pm-Midnight And Midnight To 8am** on a specified length of Foxholes Hill;

Lympstone: **No Waiting At Any Time** on a specified length of The Strand;

Newton Poppleford: **No Waiting At Any Time** on a specified length of Little Down Orchard;

Otterton: **No Waiting At Any Time** on a specified length of Church Hill;

Ottery St Mary: **No Waiting At Any Time** on specified lengths of Chapel Lane and The College;

Seaton: **No Waiting At Any Time** on a specified length of Marlpit Lane;

Sidmouth: **No Waiting At Any Time** on specified lengths of Arcot Park, Bickwell Valley, Boughmore Road, Fortfield Terrace, Kestell Road, Sid Park Road and Sid Vale Close;

West Hill: **No Waiting At Any Time** on a specified length of Bendarroch Road;

Whimpe: **No Waiting At Any Time** on specified lengths of The Square;

Woodbury: **No Waiting Mon-Fri 8:30am-4:30pm** on a specified length of Castle Lane; **School Entrance Keep Clear - No Stopping At Any Time** on a specified length of Castle Lane
