## 72. Decisions

To note planning decisions made by East Devon District Council:

a) 24/1484/TRE – Hamilton Lodge, Colyford Road, Seaton Oak tree: 2-3m crown reduction – REFUSED. The oak tree in the application is easily visible from the public realm and makes a valuable addition to amenity and to the character of

the locality. The proposed pruning of the tree has not been justified in the application and would detract from the appearance of the tree and the amenity it provides. The harm is considered not to be justified and the Council refuses consent for the proposed works.

- b) 24/1276/FUL 11 Townsend Avenue, Seaton Roof installation of three dormer windows and solar panelling to south facing elevation – APPROVED with conditions.
- c) 24/1327/FUL Portlight, Bunts Lane, Seaton Construction of extension to existing garage APPROVED with conditions.
